

PUBLIC NOTICE (Case No. 139 of 2020)

Inviting Suggestions/ Objections on Amravati Power Transmission Company Limited's Petition for proposed changes in shareholding pattern of the Company

1. Amravati Power Transmission Company Limited (APTCL) has filed Case No. 139 of 2020 before the Maharashtra Electricity Regulatory Commission (MERC) for taking on record the proposed changes in shareholding pattern of APTCL under Clause 5.2 of the Transmission Licence No. 3 of 2010 dated 30 December, 2010 granted to APTCL.
2. The Commission has directed APTCL to publish a Public Notice for inviting suggestions/ objections from the Public through this Notice.
3. Salient features of the Petition:
 - a. RattanIndia Power Ltd. is a company incorporated under the Companies Act, 1956 and is engaged in the business of developing coal based thermal power projects. On 23 October 2018, 100 % shareholding of RattanIndia Power Ltd. in APTCL was transferred to RattanIndia Solar Pvt. Ltd. Subsequently, on 25 June 2019, 100 % shareholding of RattanIndia Solar Pvt. Ltd. in APTCL was transferred to Nettle Constructions Pvt. Ltd., a company incorporated under the Companies Act, 1956.
 - b. Nettle Construction Pvt. Ltd. owns 100% shareholding of APTCL. The Transmission Licence granted by MERC continues to be in the name of APTCL.
 - c. There shall be no adverse impact on Tariff on account of the proposed transaction, as the Tariff shall continue to be determined on the basis of regulated books of accounts.

Every person who intends to file suggestions/ objections, can submit the same in English or in Marathi, in writing by electronic means and should mention the full name, postal address and e-mail address, if any, of the sender. It should be indicated whether the suggestions/ objections are being filed on behalf of any organization or category of consumers. If the sender wants to be heard in person in e-Public Hearing then he should specifically mention the same at the time of filing suggestions/objections. In such cases, submission of valid email ID and Mobile Number is mandatory. The Commission, at its discretion, may permit such sender/objector to be heard in the e-Public Hearing. All participants attending the e-Public Hearing shall follow the provisions of the Commission's "Guidelines for attending Public Hearing Through Video Conference" notified on **17 September 2020** (available on the website of the Commission, www.merc.gov.in).
7. e-Public Hearing, through video conferencing will be held on **Tuesday, 09 February, 2021** at 10.30 Hrs., for which no separate notice will be given.
8. APTCL shall reply to each of the suggestions/ objections received within three days of the receipt of the same but not later than **04 February, 2021** for all the suggestions/ objections received till **01 February, 2021**. Stakeholders can submit their rejoinders on replies provided by APTCL either during the public hearing or latest by **10 February, 2021**.
